

FARM RATES

STANDARD RATE

This rate is for farms with normal household and agricultural use, served through SaskPower – supplied transformation up to and including 3000 kilovolt amperes (kVA).

MINIMUM BILL

The basic monthly charge plus \$4.869/kVA of the maximum demand over 50 kVA registered in the defined billing periods between May 1st to October 31st and November 1st to April 30th. The month containing the highest registered demand within a defined billing period will be used to calculate the minimum bill for the remainder of that period.

LOADS ABOVE 3,000 KVA

For loads in excess of 3,000 kVA, a different rate structure will apply. Please see **Customer-Owned Transformation — Power Standard Rates**.

FARM RATES

IRRIGATION RATE

This rate is for farm irrigation loads served through SaskPower-supplied transformation for the annual pumping season between April 1 and Oct. 31.

FARM RATES

IRRIGATION (INTERRUPTIBLE) RATE

This rate is for farm irrigation main pumping stations requiring in excess of 1,000 kilovolt amperes (kVA) served on an interruptible basis through customer-owned transformation, and for related booster pumps and pivot systems less than 1,000 kVA that will be inoperable as a consequence of an interruption to the main pumping station. The annual irrigation pumping season is from April 1 to Oct. 31.
